Behind the Scenes

In 1 Corinthians 12, Paul talks about the body of Christ:

"For just as the body is one and yet has many parts, and all the parts of the body, though they are many, are one body, so also is Christ. ¹³ For [m] by one Spirit we were all baptized into one body, whether Jews or Greeks, whether slaves or free, and we were all made to drink of one Spirit". (NASB)

Later in the chapter, Paul speaks of parts of the body that are less presentable but just as important to the body. The heart or liver may not be anything to look at but try going without!

When we first joined the SOWER ministry, I was not at all aware of everything that went on behind the scenes. We would sign up for a project and show up when required. We worked our tails off and fully enjoyed the blessings of serving and the great fellowship we had with fellow SOWERs. At first, I didn't think of everything that had to happen to allow us to be able to so easily travel around, serve some great ministries, and reap the blessings. Since that time, and especially during my time so far serving on the board, I have been given an opportunity to peek behind the scenes.

One role of which I was unaware is the Area Representative or AR. These 41 couples (or individuals) serve behind the scenes in a vital role. They are the primary contact for our 175ish projects, regularly communicating with, visiting, and encouraging these ministries. Simply put, the SOWER ministry could not function without everything they do.

I was also not aware of what all goes on behind the scenes with the board of trustees. I initially thought of the board as simply a decision-making group. Little did I know of all the work that is accomplished between the "decision-making" meetings. Although it is challenging at times, I have been blessed by serving in this way. Being on the board has also opened my eyes to the massive amount of work accomplished daily by our (currently volunteer) office staff.

Of course, there are many other "behind the scenes" vital roles in this ministry. I encourage you to prayerfully consider where you might be able to serve behind the scenes. If you feel led to be an Area Representative, please contact me and I can answer any questions you have and will try to find a place for you there. We would love to have a list of those willing to serve in that capacity. If you would like to serve on the board of trustees, please talk to others about that desire and be ready to be nominated to the board this next spring. If you have questions about serving on the board, please contact me or any other board member and let's talk!

Finally, thank you to everyone serving in the SOWER Ministry! Every role is vital to keeping this ministry going and allowing us to serve the Lord by serving great ministries across the US and Canada.

Have you ever wondered what your service is worth to a host? Although we do not do what we do so that we can place a value on it, I have been a numbers guy in my working career and numbers tell a story, so I wanted to look at that. At the 40th reunion one of our hosts made a

presentation that mentioned a study done by the Independent Sector, with the Do-Good Institute at the University of Maryland that placed a value of each volunteer hour at \$29.95. In other words, if a host had to hire someone to do a job or if they had an existing staff member do a job it would cost the host that amount per hour. Remember that amount includes the actual wages to the staff member, but also includes the employer's costs for social security, unemployment insurance, workers compensation insurance, etc. Curious to find out what we as a SOWER couple offered as cost savings to our host, I did a search to find that study and to find out what that dollar amount would be today. In 2023 the value of a volunteer hour had risen to \$33.49, which means that each SOWER couple, men working 72 hours and ladies working 36 hours or 108 hours total, saved the host \$3,617. And that is one couple one month. What would be the value of the SOWER Ministry in total savings to the Christian camp community? The officer provided the total number of SOWER visits that we did in one calendar year, 1,250. Stated another way would be one couple, working one month, 1,250 times. Now simple math, \$3,617 X 1,250 = \$4,521,150. Four and a half million dollars of volunteer labor in service to the Lord. To me that is a story. Is FIVE MILLION in our future? Only you can answer that. May God Bless your service in partnership with our hosts in serving the Lord.
